Dear WHRI community,

You will have received our C&W campus-wide email on June 18 about the great news regarding resumption of onsite research!

Stage 1 involved an extensive review process and more than 125 applications were reviewed-- two thirds of these which were requests to resume wet and dry lab research in non-clinical areas received approval to return. Those who have requested resumption of clinical research will be prioritized next. WHRI research management will be working alongside clinical operations directors to ensure alignment between clinical research and clinical activities resumption.

It's important to remember that this is only our first step. In Stage 2, we plan to further increase the number of people onsite. While we are looking forward to moving ahead, the timing for Stage 2 is dependent on directives from the PHO, WorkSafeBC, PHSA and UBC; the severity of the current COVID-19 pandemic in B.C.; and incidents of COVID-19 in the Oak Street campus research community.

I again want to extend my gratitude to the Working Group and the Review Committee for their dedication to this process and extra hours.
