Dear Colleagues,

Earlier this week, <u>UBC announced an open call for applications for Stage 3 funding</u> from the federal <u>Canada Research Continuity Emergency Fund</u> (CRCEF).

Investigators interested in applying for Stage 3 CRCEF funding must submit applications themselves at https://research.ubc.ca/CRCEF/Stage3 by **October 30, 2020**.

Stage 3 CRCEF funding supports direct costs of research that have been incurred to:

- maintain essential research-related commitments during the COVID-19 pandemic; and/or
- 2. ramp-up to full research activities as physical distancing measures are eased and research activities can resume.

Only direct costs of research that are **extraordinary and incremental** to those already covered by existing sources of funds and were incurred between March 15 and November 15, 2020 are eligible for reimbursement, up to 75%.

Extraordinary incremental costs are defined as:

- unanticipated additional costs that would not normally have been incurred in the absence of the COVID-19 pandemic; and
- cannot be funded by existing sources of funds.

Costs funded by all funding sources (including government) are eligible. **Salary costs are ineligible.**

Eligible expenses include:

Maintenance costs

Costs incurred within the eligible period and associated with maintaining essential research-related activities during the pandemic that are exceptional and incremental to those already covered by existing sources of funds, funded at up to 75%. This includes:

- animal and specimen care through the crisis period;
- maintenance of equipment, software, cohorts, and datasets, including warranties, licenses and service contracts;
- technological equipment for remote access to maintain assets; and,
- safety equipment for personnel dedicated to maintenance.

Ramp-up costs

Costs incurred within the eligible period and associated with full ramp-up of research activities, as physical distancing measures are eased and research activities can resume. Only costs that are exceptional and incremental to those already covered by existing sources of funds will be

supported, at up to 75% of expenses. Eligible expenses include those incurred at the project level and associated with:

- re-organizing the research environment and activities;
- additional costs to bring the research back to its pre-pandemic level, including experiments, or related to the restart of collections and datasets (e.g., population-based, environmental);
- user fees charged by shared platforms to researchers to restart research activities (e.g., animal-care facilities, digital labs);
- re-scheduling and restarting human and clinical trials;
- exceptional costs to access special facilities, shared platforms and resources, knowledge transfer meetings and workshops;
- restarting, reassembling and safety checks of equipment and facilities;
- reacquiring lost and donated laboratory and field supplies and equipment, reagents, perishable materials, laboratory animal and other living specimens; and,
- personal protective equipment and related items for research personnel.

In Stage 3 of the CRCEF, UBC's Research Finance team and the Oak Street campus Research Institutes will not be contacting PIs to identify those eligible for funding, as they did in Stages 1 and 2 of the CRCEF. Stage 3 is an open call for applications and PIs must submit their own claims. **The deadline for submission is 11:59 p.m. on October 30, 2020.**

For PIs who hold eligible costs both in UBC and PHSA accounts, please clearly indicate on the application form where the funding is held.

If you applied to resume onsite work during Stage 1, you do not need to apply again. Please email Todd Jacques at tjacques@bcchr.ca with any updates to your onsite personnel and research team safety plans.

If your team includes any new personnel or existing personnel who require training on new tasks, you are also required to create a written training plan for these staff. This could include detailing whether

training will happen virtually or in person and the types of PPE that will be used to protect all those taking part.
